



## **MEMORANDUM OF UNDERSTANDING**

between

Department Bakery and Confectionary Goods Technology of NATIONAL UNIVERSITY OF FOOD TECHNOLOGIES.

Ukraine

and

Department of Technology and Quality of Plant Products of SLOVAK UNIVERSITY OF AGRICULTURE IN NITRA,

Slovakia

- Department Bakery and Confectionary Goods Technology of National University of Food Technologies and Department of Technology and Quality of Plant Products of Slovak University Of Agriculture In Nitra wish to collaborate in order to benefit their research and teaching activities, and to further the internationalisation of both universities.
- 2. The purpose of this **Memorandum of Understanding** (MOU) is to establish a framework within which co-operation may develop between the two institutions. This will occur within the context of the regulations and policies of each university, and subject to the availability of resources.
- 3. Co-operation between the two universities may include such activities as:
  - Exchanges of students and academic staff
  - Joint research activities, including seminars, conferences and public lectures
  - Exchange of publications, academic materials and other information
  - Collaborative degree programs

- Other projects for mutual benefit that are agreed upon by both parties
- 4. Specific programs or activities will be undertaken under this MOU only after the written agreement of both universities. The terms and conditions of the program or activity, including any financial arrangements, shall be set out in a written Agreement signed by an authorised representative of each university.
- 5. Both parties shall designate a liaison office for this MOU and for any subordinate agreements under this MOU.
- 6. This MOU comes into effect when the last signatory signs. It will remain in effect for a period of 5 years from that date. Not less than six months prior to its expiry, the two universities will review its operation and decide whether or not to renew it. Any such renewal shall be signed by an authorised representative of each university, and may include variations to this MOU.
- 7. This MOU may be terminated by the written mutual consent of both universities, or by either university giving 60 days written notice to the other university.
- 8. This MOU places no financial or legal obligations on either of the universities, nor does it create any legal relationship between them.
